

## **WWW.STARTUPNAMAXA.PL PRIVACY POLICY**

1. Pursuant to the Personal Data Protection Act of 29 August 1997 (Journal of Laws from 2005 item 2135) the User grants their consent for processing their personal data by the Operator which is provided on the website at the following domain [www.startupnamaxa.pl](http://www.startupnamaxa.pl) ("Website").
2. The Operator of the data is Good Media Foundation (Polish registered name: Fundacja Dobrych Mediów) with the seat in Warsaw, al. Niepodległości 245 lok. 17, 02-009 Warsaw, entered into the register of entrepreneurs and register of associations, and other social and professional organisations, foundations and public healthcare centres kept by the District Court for the Capital City of Warsaw, in Warsaw, 12th Business Department of the National Court Register with the following number: KRS 0000384316, VAT No. 5252518868, Company Reg. No. (REGON) 144081797 ("Operator").
3. The Operator manages the website in order to collect signatures expressing support for a petition which aims at appointing St. Maximilian Kolbe as the patron of entrepreneurs and start-ups. Details of the petition can be found on the Website.
4. The Operator processes personal data of the Website Users in the scope necessary to fulfil the aim specified in item 3 and for the purpose of executing auxiliary campaigns in relation to the aim specified in item 3.
5. The Operator can store personal data of Users also after submitting the petition specified in item 3 in order to execute auxiliary campaigns.
6. The Operator is in possession of IP addresses of Users, stored for a period necessary to fulfill the aim specified in item 3. The Operator is also in possession of a site from which the User was brought to the Website. Such information is processed anonymously.
7. Personal data is collected only when it is provided to the Operator when signing the petition. Provision of data and signing the petition is voluntary.
8. Personal data will be shared with third parties in the scope necessary to ensure proper operation of the Website and to fulfill the aim specified in item 3.
9. The Operator is highly concerned about maintaining privacy of the Users and protecting their personal data. As the data administrator, the Operator ensures safety of personal data provided by the Users. Such data is specifically protected and secured against access of unauthorised parties. The Operator guarantees that the Users will be entitled to exercise rights resulting from the Personal Data Protection Act in particular the right to reviewing their data, the right to updating the data and the right to making an appeal in cases specified in the Act.

10. The Operator declares that it uses cookie files for which the User grants their consent.

11. Cookie files are text files containing information downloaded by the User's end device during a visit on the Website. Cookie files are sent from the User's browser to the page from which they were downloaded during each visit of the User on the Website.

12. The Operator uses two types of cookie files:

- a. session cookies which are stored on the User's device only for the time when the web browser is active
- b. persistent cookies which are stored even after terminating the Website visit.

13. The User may submit a request to the Operator to cease the processing of the User's data. Such a request will be immediately considered by the Operator.

14. The Operator reserves the right to disclose selected personal data of the User to the respective state authorities which submit a justified request for obtaining such data on the basis of the applicable legal base and pursuant to the applicable laws. The Operator shall immediately inform the User to whom the data disclosed relates, about this fact.
